#### **Network**

Before discussion the internet first of all we should discuss about the network, because if our concept will not be clear about the network then we cannot understand concept of internet. So let us start the discussion of the network. *What is meaning of the network ....* ?.Basically, *network word made-up with two words.* Next I am going to split this *Network Word*.

#### Net/work

Net + Work
Web/cobweb + task/function

It means like the spider web (cobweb) some task/function/work is happening so on this concept something is running. What........? Once again

All of you consider that when two or more than two railway stations are connected with railway tracks or two or more than two houses are connected to the roads. These interconnections are called *network* between railway stations and tracks and between houses and roads.

#### Network

"In information technology a network is a series of points or nodes interconnected by communication path."

Note: A device, generally the computer that is directly attached to the network, is called a node

### Computer Network

A **computer network** is a collection of two or more than two where components interconnected by communication channels that allow sharing of resources and information.

#### **Types of Computer network**

There are three different types of network for different purpose:

#### LAN (Local Area Network)

A Local Area Newtwork is a network that connects computers and devices in a limited geographical area such as home, school, computer laboratory, office building, or closely positioned group of buildings.

#### **Characteristics:**

- (i) A diameter not more than a few kms.
- (ii) A total data rate of at least several Mbps.
- (iii) Complete ownership by a single organization.

#### MAN (Metropolitan Area Network)

A Metropolitan area network is a large computer network that usually spans a city or a large campus.

#### Characteristics:-

- (i) Covers entire city, but uses LAN technology.
- (ii) Have data rates below 1 Mbps.
- (iii) Owned by multiple organizations.

#### WAN (Wide Area Network)

A (WAN) is a computer network that covers a large geographic area such as a city, country, or spans even intercontinental distances, using a communications channel that combines many types of media such as telephone lines, cables, and air waves.

- 2. Connects many sites spread across large geographic distances with many computers at each site.
- 3. Provides sufficient capacity to permit the computers to communicate simultaneously.



#### **Topologies**

A topology is the layout of the network components or the pattern of arrangement of nodes that are connected using cables in a local area network (LAN) environment. There are following study of network topology recognizes eight basic topologies

- 1- Bus Topology
- 2- Ring/Circular Topology
- 3- Star Topology
- 4- Tree Topology
- 5- Mesh Topology
- 6- Point-to-Point Topology
- 7- Daisy Chain Topology
- 8- Hybrid TopologY



- **1- Bus Topology:** In this topology, the computers are connected to form a network through a single cable that runs from one computer to another. Each node can send messages to all the other nodes in the network. If a node sends a message to a particular node in the network, only that node accepts the message and all the other nodes ignore it.
- 2- Ring Topology: In this topology, each computer is connected to the computer next to it, Hence, each computer is connected only to two of its neighboring nodes. All the components of the network are connected to a main cable and form a circle. When a node sends a message to any other node on the ring, the message travels (either in clockwise or counter clockwise direction) through every other node in the ring until it reaches its destination node. In this topology, the data is transmitted in one direction and if one node fails to transmit the data the entire network fails.
- **3- Star Topology:** In this topology, all the computers are connected to a central device. The central device can be a switch or a hub. The central device is usually connected to the server and it receives the data from a node and sends it to the destination node.
  - 4- Tree Topology: Tree topology is the combination of Bus and Star topology.
  - 5- **Mess Topology:** Every computer has a direct connection to every other computer on the network.

#### 6- Point-to-point (telecommunication)

In telecommunication, a **point-to-point** connection refers to a communications connection between two nodes or endpoints. An example is a, in which one telephone is a connected with one other, and what is said by one caller can only be heard by the other. This is contrasted with a communication topology, in which many nodes can receive information transmitted by one node.

#### 7- Daisy chain (electrical engineering)

In electrical and electronic engineering a daisy chain is a wiring scheme in which multiple devices are wired together in sequence or in a ring. Daisy chains may be used for power, analog signals, digital data, or a combination thereof.

#### 8- Hybrid

Hybrid networks use a combination of any two or more topologies. A Star Bus network consists of two or more star topologies connected using a bus trunk (the bus trunk serves as the network's backbone).

#### **History of Internet**

In 1969, the Department of Defense (DOD) of United States of America started a network called ARPANET (Advanced Research Projects Administration Network). It was started with one computer in California and three in Utah

Later, the military allowed universities to join the network for sharing the hardware and software resources, a number of other networks were developed during the late 1970 and early1980, with BITNET and CSNET among them. BITNET which is acronym for Because It's Time Network began at the City University of New York. It was provide electronic mail and file transfers. CSNET, which is an acronym for Computer Science Network, Its initial purpose was to provide electronic mail. for a variety of reasons, neither BITNET nor CSNET became a dominant national network.

A new national network, NSFnets, was created in 1986. National Science Foundation (NSF) initially connected the NSF-funded supercomputer centers at five universities. By 1990, NSFnet had replaced ARPAnet for most nonmilitary uses and wide variety of organizations had established nodes on this network. By 1992, NSFnet connected more than 1 million computers around the world. In 1995 a small part of NSFnet returned to being a research network. Then it grew bigger and gave birth to the present-day very popular Internet. Internet

#### Internet is a network of networks. or

It is an interconnection between several computers of different types belonging to various networks all over the world.

#### How does internet work?

When information is passed from one computer system to another it is broken up into pieces called packets using the TCP and IP protocol. a message consisting of not more than 1500 bytes or characters is put into a packet. Each packet has the address of sender and the destination. These addresses are called IP addresses.

The packets are passed from one network to another until they reach their destination. At the destination the TCP software reassembles the packets into a complete message, if packets are lost or damaged, a request is sent to resend them. it is not necessary for all packets in a single message to take the same route through the internet or for the same message o take the same route each time it is sent.



#### **Stateful Multilayer inspection (SMLI):-**

It is third generation of firewall technology and usually combines the facilities of above two. It is completely transparent to both users and applications.

#### **Encryption/Decryption Methods:-**

It is a method of converting plain text to cipher text and cipher text to plain text.





Typical formal definitions of software engineering are: "the application of a systematic, disciplined, quantifiable approach to the development, operation, and maintenance of software";

<u>Development</u> of <u>procedures</u> and <u>systematic</u> <u>applications</u> that are used on <u>electronic machines</u>. <u>Software engineering incorporates</u> various accepted <u>methodologies</u> to <u>design</u> software. This particular type of engineering has to take into <u>consideration</u> what type of machine the software will be used on, how the software

will work with the machine, and what elements need to be put in place to ensure reliability.




# **Spiral Model:- Most Important**



- Case 3:- Execute all loops at their boundaries.
- Case 4:- Exercise Internal data structure.

# **Black Box testing (System testing):-**

It is also known as **behavioural** testing, focuses on the functional requirements of the s/w. It arises following questions.

- ❖ How are the boundaries of a data class isolated?

Verification :- "Are we building the product right?"
Validation :- "Are we building the right product?"

# **Special System Tests:-**

There are other six tests which fall under special category.

- <u>Peak Load Test:</u> It determines whether the system will handle the volume of activities that occur when the system is at peak of its processing demand.
- <u>Storage testing:</u>-It determines the capacity of the system to store transaction data on a disk or in other files.
- <u>Performance Time testing</u>:-It determines the length of time system used by the system to process transaction data.
- Recovery testing:-This testing determines the ability of user to recover data or restart system after failure.
- <u>Procedure testing</u>:-It determines the clarity of documentation on operation and use of system having users to do exactly what manual request.
- <u>Human Factor testing:</u>-It determines how users will use the system when processing data or preparing reports.



Second, most studies tend to overlook the confusion inherent in system development the constraints and assumed attitudes.

Feasibility is the determination of whether or not a project is worth doing. The process followed in making this determination is called a feasibility study. This type of study determines if a project can and should be taking. Once it has been determined that a project is feasible, the analyst can go ahead and prepare the project specification which finalizes project requirements. Generally, feasibility studies are undertaken within tight time constraints and normally culminate in a written and oral feasibility report. The contents and recommendation of such a study will be used as a sound basis for deciding whether to proceed, postpone or cancel the project. Thus, since the feasibility study may lead to commitment of large resources, it becomes necessary that it should be conducted completely and that no fundamental errors of judgments are made.

## **Technical feasibility:-**







## Cost/Benefit Analysis:- (Minimum input and Maximum Output):-


Benefits of project include four types.



#### **Regular Expressions**

Just as finite automata are used to *recognize* patterns of strings, regular expressions are used to *generate* patterns of strings. A regular expression is an algebraic formula whose value is a pattern consisting of a set of strings, called the language of the expression.

### Operands in a regular expression can be:

- *characters* from the alphabet over which the regular expression is defined.
- *variables* whose values are any pattern defined by a regular expression.
- *epsilon* which denotes the empty string containing no characters.
- *null* which denotes the empty set of strings.

## **Operators used in regular expressions include:**

• <u>Union:</u> If R1 and R2 are regular expressions, then R1 | R2 (also written as R1 U R2 or R1 + R2) is also a regular expression.

PL(Pumping Lemma):- Important Question

Let L is a regular language, then there exists a constant n such that every string w in L, of length n or more, can be written as w=xyz

#### **TM performs Computer functions:-**

A Turing machine M accepts input w if a sequence of configurations  $C_1, C_2, \ldots, C_k$  exists, where

# Decidable and Undecidable Problems:-


A class of problems with two outputs "Yes" or "no" is said to be <u>decidable(solvable)</u> if there exist some definite algorithm which always terminates (halts) with one of two outputs "yes" or "no".Otherwise the class of problems is said to be <u>undecidable (unsolvable)</u>.

# **Halting Problems:-**

Given a Turing machine M and an input w to the machine M, determine if the machine M will eventually halt when it is given input w.



H generate an output "halt" if H determines that M stops on input w or it outputs "loop" otherwise



#### <u>Undecidability of Post Correspondence Problem(PCP):-</u>

Let  $\Sigma$  be an alphabet, and let L and M be two lists of nonempty strings over  $\Sigma$ , such that L and M have the same number of strings. We can represent L and M as follows:

- $\bullet$  (ω(n<sup>2</sup>) is pronounced as little omega of n<sup>2</sup>)

## **Classification of problems:-**

#### What is $\underline{P}$ :-

P is the set of all decision problems which can be **solved** in *polynomial time* by a *deterministic Turing machine*. Since they can be solved in polynomial time, they can also be verified in polynomial time. Therefore P is a subset of NP.

What is NP:-

NP is the set of all <u>decision problems</u> (questions with a yes-or-no answer) for which the 'yes'-answers can be verified in polynomial time  $(O(n^k)$  where n is the problem size, and k is a constant) by a <u>deterministic Turing machine</u>. Polynomial time is sometimes used as the definition of fast or quickly.

# NP Completeness:-

A nondeterministic Turing machine can do everything a regular computer can and more. This means all problems in P are also in NP.

Or

**Definition:** - A problem is said to be Nondeterministically Polynomial (NP) if we can find a nodeterministic Turing machine that can solve the problem in a polynomial number of nondeterministic moves.

#### NP-hard:-

If a problem is NP-hard, this means I can reduce any problem in NP to that problem. This means if I can solve that problem, I can easily solve any problem in NP. If we could solve an NP-hard problem in polynomial time, this would prove P = NP.

#### NP-complete:-

A problem is NP-complete if the problem is both

- NP-hard
- NP.
